








CalAIM and Transformation in Medi-Cal

- Medi-Cal is working to build a more coordinated, person-centered, and equitable health system that works for everyone
- California Advancing and Innovating Medi-Cal —
 known as CalAIM is a far-reaching, multiyear plan to
 transform California's Medi-Cal program and to make it
 integrate more seamlessly with other social services



Enhanced Care Management (ECM)

Enhanced Care Management (ECM) is a new statewide Medi-Cal benefit available to eligible members with complex needs, including:

- Access to a single Lead Care Manager who provides comprehensive care management and coordinates their health and health-related care and services.
- Connections to the quality care they need, no matter where members seek care—at the doctor, the dentist, with a social worker, or at a community center.

What is ECM?

ECM is a statewide Medi-Cal MCP benefit to support comprehensive care management for eligible members with the most complex needs

For MCP members with higher- and medium-rising risk

Basic Population Health Management *For all MCP members*

Transitional Care Services

For all MCP members transitioning between care settings




Total Number of Members Who Received ECM in Any County

Q4 2023 data release planned for June / July 2024

- <u>Report</u> provides 1st public release of Children & Youth POF data, with data through Q3 2023
- » Provides key public updates about ECM implementation
 - Enabling MCPs to understand performance relative to their peers
 - Supporting collaboration between stakeholders on ECM and CS implementation
- » Includes state-, county-, and plan-level data. Summarizes cumulative and quarterly enrollment trends for the two programs
 - Total members and members under age 21 (the age cut-off for most Children & Youth POFs) utilizing ECM in each quarter


ECM Implementation Data

ECM Implementation Data

- Enhanced Care Management for most Children and Youth Populations of Focus (POFs) launched on July 1, 2023
- The first datasets inclusive of the Children and Youth POFs were released this month. They reflect initial enrollment data for Q3 2023 (July 1, 2023 September 30, 2023)

ECM Enrollees by Age Statewide

Age 21+	79,390

ECM Penetration Rates

- Penetration Rate = The percentage of all MCP enrollees who were enrolled in ECM at any point in the last 12 months.
- Note that not all MCP enrollees are eligible for ECM. They must meet POF criteria.



CalAIM Implementation

- Children's Hospital Los Angeles is a safety net hospital delivering quarternary pediatric health care
 - >73% of patients served by CHLA are Medi-Cal beneficiaries
 - Leading provider of CCS specialty care with more than half of inpatient admissions related to CCS conditions
 - >60% of populations served with limited English proficiency




- CalAIM-focused pediatric care delivery including:
 - Health Related Social Needs
 - Community Health Worker integration into care team
 - Enhanced Care Management



CalAIM at CHLA

- Health Related Social Needs
 - Population-focused screening:
 - Behavioral Health
 - Housing
 - Food
 - Utilities
 - Digital Access
 - Transportation
 - Interpersonal Safety

- Community Health Workers
 - Employed team member at CHLA
 - Engage in peer-to-peer services integrated into clinical teams
 - 13+ FTE working at CHLA and in community






CalAIM ECM at CHLA

- Since July 2023, contracted across 4 counties, 8 Managed Care Plans
 - Child & Youth Populations of Focus:
 - California Children's Services (CCS)
 - Serious Mental Illness (SMI) + Substance Use Disorder (SUD)
 - Child Welfare
 - Birth Equity

CalAIM ECM at CHLA

Successes:

- CalAIM has enabled CHLA to hire a community health workforce (CHW)
- Integration of CHW into clinical care teams
- Intentional peer-to-peer support to build trust among patients, families, staff, and clinicians
- Extension of CHLA care into the community with visits to markets; colleges; and parks— meet patients where they are
- Enable patient-focused care to reduce health disparities by recognizing healthrelated social needs and truly care for our patients and families

• Challenges:

- Applying the ECM model to pediatric populations (vs. adult-based care)
- Referrals from MCPs for sensitive populations such as SMI/SUD and Child Welfare
- Challenges in enrolling ECM for FFS populations (Straight Medi-Cal)
- Every MCP has different requirements
 - Portal vs Email vs Fax
 - Inability for bulk file transfer
 - Weekly vs Monthly vs Quarterly Audits
 - RTF/OTF file formats are different than the state standard
 - Lack of standard FFS units for billing
 - CMS 1500 vs UB04 claims submission
 - Lack of standardized referral forms
